Businesses are permitted to display temporary signage **up to 30 days per calendar quarter.**

A separate permit is required for each separate display of signage within the quarter.

Special Event Temporary Signage

Each business is permitted one Special Event permit every 24 months and is permitted up to 30 days.

Multi-Family and institutional uses in residential zones may have a Special Event permit issued up to 12 times per year and can be displayed up to 72 hours

The following types of signage are only permitted under a special event signage permit.

SIGN CODE GUIDE

A Temporary Sign, such as a banner, is a sign erected for a limited time to advertise special business, real estate or other events. All uses within the City are permitted one Temporary Sign Permit per quarter to be displayed up to 30 days.

Typically, the City will issue a temporary sign permit over the Counter at the time the application is made.

Special Event signage, such as banners, balloons, or search lights, are typically used for Grand Openings and other special events taking place at a business, school, or office. Each business is permitted one Special Event sign permit every 24-months. Multi-family uses and institutional uses in residential zones are permitted up to 12 special event sign permits per year.
