#### Official Contest Information

How do you reduce waste, reuse items, and/or recycle correctly? Share a drawing, photo, photo of an art piece, or a short video (60 seconds or less) that you created telling us about your experience *Re-Thinking Waste*. You can win up to \$350 for your submittal. Winning entries will be shared on City of Tukwila and Waste Management websites, social media, and featured in an Earth Day news release.

### What should my film or photo include?

Tell us your tips to teach others how to reduce waste, reuse items, or recycle properly. Here are some examples:

- Show what you do at home to reduce waste.

- Show creative ways to reuse items.
- Get creative and have FUN!

Submissions will be judged by a City of Tukwila and Waste Management panel based on creativity, relevance to the waste reduction/recycling theme, quality, effort, and persuasiveness. Waste Management reserves the right to exclude any entries deemed non-suitable or inappropriate.

\*\* If chosen as a winner, you may be invited to a city council presentation and your artwork may be shown in public spaces, such as at the Tukwila library, a City park as a poster or a banner. \*\*

#### Who can enter?

- All Tukwila School District Elementary, Middle, or High School Students.
- All Elementary, Middle, or High School Students who live in the City of Tukwila but go to school elsewhere.

#### When are entries due and when are finalists announced?

- Entries are due by Friday, March 31st 5:00 PM
- Finalists will be announced by noon on Friday, April 21st, the day before Earth Day.

#### How do I submit my entry?

- If your video file is too large to send via email you can:
  - Upload it to YouTube or Vimeo and send us a link (you will need to have an account)
  - o Use a free program to condense the file size of your video so it can be sent via email
- Videos should be 60 seconds or less and format should be in \*.mov, \*.mpr, \*.mpeg or \*.avi format.
