Additional Requirements	
NOTE: 2021 ANSI MH16.1 Design, Testing, and Utilization of Industrial Steel Storage Racks Exit access. Two exits are required for storage areas serving more than 49 occupants. Where two exits are required, identify the egress path (on the plan) connecting the two required exits. Construction rack details. Indicate the intended commodity to be stored on racks. All storage racks shall be mechanically anchored in place to resist displacement. Storage racks eight feet or greater in height shall be engineered and anchored or braced to resist overturning or displacement due to earthquake events.
