Plans – Must be legible. Please ensure current IBC/IRC codes are clearly stated.	Attachment File Name
<a href="#">Architectural Plans</a> Provide a detailed description of the proposed work. <b>Floor Plan:</b> Submit a floor plan showing all areas of exterior work will be performed. <b>Window Specifications:</b> Indicate the type of windows to be installed (e.g., vinyl, wood, aluminum). Provide U-values for each window type in compliance with the current energy code. Ensure Safety Glazing is identified as required. <b>Window Sizes and Egress Compliance:</b> Specify the dimensions of all windows. Clearly identify bedroom windows and confirm they meet building emergency egress. <b>Window Removal and Insulation:</b> Identify any windows to be completely removed and filled in. Specify the type of insulation to be used in wall cavities and provide details on wall sheathing and finishes. <b>Window Enlargements:</b> For windows to be enlarged, specify the new header sizes. Include detailed framing information to ensure structural compliance. <b>Construction Details for Exterior Enclosure:</b> Provide comprehensive construction details, including material specifications, for the building's exterior enclosure. <a href="#">Structural Plans</a> - If required for opening expansion. Must meet perspective design out of the IRC or be prepared by a registered design professional	Structural Plans
<a href="#">Special Inspection</a> - Required for Multi-Family projects only.	Special Inspection
Additional Requirements for Multi-Family	
Multi-unit residential buildings shall require <a href="#">Special Inspections</a> by Third Party inspector. (HB 1848). Plans and documents shall be prepared by or under the direction of an architect or engineer.	
Additional permits may be required
