

Initially, I saw Tukwila mainly as a mall, but my viewpoint evolved after settling into my home and discovering the city's rich geographical history and opportunities. I'm deeply passionate about serving my community, preserving its heritage, and embracing new possibilities.

My qualifications are rooted in both professional knowledge and commitment, aligning with my personal and professional goals to pursue ongoing education and continuous growth.
