### **City Council Letter of Consideration**

I have been in discussions with the organizations I am involved in about a 2025 Tukwila City Council run. This seemed like a great way to get my foot in the door.

After floating the idea past everyone, they thought there was no harm in throwing my hat in the ring.

I belong to three organizations that regularly do work across King County.

- Transit Riders Union (TRU), volunteering and advocacy
- Seattle DSA- South King County Branch, volunteering and advocacy
- Progressive Victory, online organizing of volunteers

I regularly participate in advocacy based on the needs of everyday folks, and uplifting everyone's voice in a democratic manner.

In Tukwila specifically I was a core volunteer on the TRU's minimum wage campaign, and am currently involved in their Renter's Bill of Rights campaign. When I can, I go door to door in my neighborhood helping folks with mutual aid activities- distributing food, hygiene products, and cleaning supplies.

I also have a garbage grabber, so I am able to safely pick up garbage from trails in my neighborhood, usually when I feed the stray cats and raccoons.

I am currently a member of the Financial Sustainability Committee, and plan to apply for resident committees for subjects I have knowledge in often.

- Housing Supply Shortage, specifically permanently affordable housing
- Food Insecurity and local micro food deserts
- Public Transit, Bus frequency/availability, lack of routes

- Ongoing gentrification of town, pricing out long terms residents, income inequality
- Ensuring all residents have the ability to partake in resources our community offers, regardless of income
- Youth and Senior Care

Describe your understanding of the importance of regional collaboration and partnership in city government.

The basis of building society is building community. Regional collaboration is a piece of that—similar to our joining of the Puget Sound Regional Fire Authority. I would love to see Tukwila spearhead creating public housing structures based off of the Vienna Model (Capital of Austria) in collaboration with as many South King County cities as possible.

Regionally, we deal with many of the same issues on the south side. We are not alone, so we should not act like we are.

Summarize your experiences working collaboratively with others from different backgrounds. My philosophy for collaboration is to always speak and interact with the intent to listen and understand, not just reply. Knowing when to be quiet & Asking lots of questions. I do not believe there is such a thing as bad or unnecessary questions. Questions for clarification are always relevant to someone in the room. I believe it is very important to develop spaces in a way where everyone gets a voice, and develops an inherently marginalized first orientation. (BIPOC & Disabled Individuals, Working class) Those in a space should be a part of leading the space.

I believe government and leadership should be from a place of service. People should be uplifted into positions of power by those they will serve. When everyone around me starts asking, "When will you run for city Council?" I figured that was a good indicator.

I am a disabled non-driver, which is a perspective I feel the Council could use.

Since I am planning to run in 2025, I feel being appointed now would be a great help to that. This would give me the opportunity to learn the ropes before a longer term.
