Why are you interested in serving as a Tukwila City Councilmember?

I'm eager to serve the community and the City of Tukwila as a member of the Tukwila City Council. I'm confident I can add value.

Passion. I care about the well-being of the community and the future of the city. Tukwila is my roots, my heritage. I've lived here essentially all my life, as has my family for several generations. I embrace and value Tukwila's cultural richness and the vibrancy of being the City at the crossroads. My wish for Tukwila is one of health socially, financially and economically - where the community feels life is good.

Experience. My tenure as the city's Finance Director for seven years and Deputy Finance Director for three gave me in-depth institutional knowledge of the City, its finances and operations. What do you think are the most important issues facing Tukwila in the next 2-4 years?

A City emergency has been declared. Making progress on this issue is paramount. Other important issues include:

- Housing/homelessness in general and relative to the emergency declaration/asylee situation
- Crime reduction and improved City image important to both the business and residential community.
- Financial stewardship ensuring the City's resources are used wisely and equitably in pursuit of the City's vision and mission
- City facilities optimal utilization and functionality.
- Service delivery ramp up especially with the development of Tukwila South
- Communication, community engagement and unity.
- Comprehensive Plan development and adoption

Describe your understanding of the importance of regional collaboration and partnership in city government.

Regional collaboration is necessary for issues that cross jurisdictional boundaries or require resources beyond the budgets of local jurisdictions. A coordinated approach often creates a better and more comprehensive solution. We are in this together,

Because Tukwila is integral to the region and most regional policies and decisions directly affect the City, it's imperative to have City respresentation on the regional boards and commissions so our perspectives can be shared and our interests advocated.

Examples of issues that cross jurisdictional boundaries include housing/unsheltered population, transportation, environmental issues. Examples of Tukwila's partnership with other jurisdictions to address expensive and complex issues include the creation and operation of the SCORE jail and the Valley Communications 911 dispatch center.

Summarize your experiences working collaboratively with others from different backgrounds.

Each of us brings with us a unique background yet we have much in common. I believe the key to successful collaboration is to find that commonality and build on it.

I've worked collaboratively with others from different backgrounds in the Tukwila School District, at the King County Housing Authority and the City of Tukwila. As a manager at the KCHA, my first hire was a woman born and raised in China who had lived in the United States for only a few years. Her personal story is compelling. As a teenager, she was subject to the Chinese Cultural Revolution and, under the Down to the Countryside movement, was removed from her family in Beijing and dispatched to Mongolia where she performed manual labor under harsh conditions for several years. When she returned home her parents barely recognized her. After competing for and earning entrance, she completed her education, then became a reporter for a Shanghai based media organization and in 1999 traveled to Seattle to cover the WTO riots. Soon thereafter, she relocated to the USA arriving with just \$50. She went on to achieve much and enjoy many successes.

As the City's Finance Director, I hired three Foster High School students to serve as interns in the finance department. Each had varied backgrounds and unique and inspiring personal stories.

As a life-long resident and former City of Tukwila Finance Director and employee, I'm familiar with the City. I've lived much of its history, benefited from its services, and witnessed its challenges and successes. I am well informed on the City's operations - it's departments and services - and its finances - revenue sources, major expenditures and capital investments, budget, Financial Planning Model and financial reports.

Having worked for the King County Housing Authority for 10 years, I have experience with housing issues and solutions. Additionally, I served as a CPA in an international public accounting firm and as Director of Internal Control for a Fortune 500 company.
