Why are you interested in serving as a Tukwila City Councilmember?

I have been a resident of Tukwila for 15 years, and I am excited by the opportunity to serve on the Tukwila City Council and advocate for all residents. I think it is a great way to continue my community-focused work. I bring a unique and valuable perspective to the council, including being an immigrant, a woman of color, a small business owner, a strong knowledge of the nonprofit sector, and being active in the community. I want to ensure Tukwila remains welcoming to all races and cultures and continues developing a family friendly city.

Describe your background in community service, including any volunteer work you have done in or around Tukwila.

Most of my professional life has been about community service. I began volunteering in the 90s for a small nonprofit teaching English to non-English speakers. I soon became heavily engaged with the organization. I served on its board for eight years and was Board Chair for 4 of those years. Since then, I served on various other nonprofit boards; more recently, I served on the Children's Alliance board (also eight years) and led the hiring of the executive director--a long and arduous process. I serve on the Equity and Social Justice Commission for two terms here in Tukwila. I advocated for a bicycle rack outside the Tukwila pool, participated in various marches during the Black Lives Matter crisis, and volunteered at the food bank. I work hard to instill these values in my son so that when he can, he can also give back to his community.

What do you think are the most important issues facing Tukwila in the next 2-4 years?

Housing and community growth must be addressed in 2-4 years. Tukwila needs to continue building community, and we can do this by making the city more walkable. We need to help the neighborhoods feel connected, and we need to encourage more small businesses to areas where there are none and help current small businesses stay anchored so they succeed. We need to leverage the fantastic resources of the South Center Mall and those not utilized by residents, such as the trails and the Tukwila Pond. The economy will always be important to Tukwila because it depends on the sales tax economy of the mall. We also need to support our police and fire departments as we face high crime and safety issues and the opiod crisis. Finally, we need to focus on people experiencing homelessness. I think the city should be a strong partner with those organizations helping those most vulnerable in our community. We can do many of these things through strong regional relationships, so we don't feel we have to tackle significant issues ourselves.

Describe your understanding of the importance of regional collaboration and partnership in city government.

Regional collaboration is incredibly important because Tukwila's challenges don't start or end in Tukwila. Only by working with institutions like the Sound Cities Association, Association of Washington Cities, Sound Transit, King County, and other cities and county governments can we make progress on solving significant issues.

Summarize your experiences working collaboratively with others from different backgrounds.

My professional career is built around working with people of different backgrounds. As a private consultant, I worked with organizations representing immigrant families, the unhoused, and those living in rural areas. I worked with these communities by training them on how to use their voice to create change. I also am comfortable being in situations where white men hold the decision-making power. In my current work, I bring people together to work in a coalition to solve problems. Here, I led efforts to bring an equity lens to our work. As a non-profit leader, I helped build our board and recruit a new executive director that reflected social justice and inclusive values. This idea of working collaboratively with people of different backgrounds is precisely why I want to serve on the city council. We need to continuetowards striving to improve representation and outreach. Our city government needs to be reflective of the community we live in.

Discuss your qualifications relevant to the position of Tukwila City Councilmember.

I am highly qualifed to be on Tukwila's City Council. I hold a masters degree in social work, I have worked for the last 30 years doing public policy advocacy and fully understand the legislative process. While I don't know all of the issues, I know how invstigage and learn. I currently work for a nonprofit dedicated to creating economic security for Washington families. We work with our state's legislature to ensure good policies as passed and developed. I am also qualified because I am a Tukwila resident and deeply care about its wellbeing.
